About PRINCE2

PRINCE2 (**PR**ojects **IN** **C**ontrolled **E**nvironment) is a structured method for the effective and efficient management of projects. It is a generic **best-practice** approach for the management of **all types of projects** and it has become the de facto standard for organising, managing and controlling projects.

PRINCE2 Benefits

- ▶ **An organised and controlled start**, ie making sure there is a valid reason for the project and that all people and resources have been organised and are ready for the project
- ▶ **An organised and controlled middle**, ie once the project has been organised and has started, making sure its validity is maintained and the work carried out is controlled throughout the project life
- ▶ **An organised and controlled end**, ie a controlled end is always better than the natural tendency to drift into the operational life of a project's product, hence we need to make sure the Project deliverable is accepted by our client before closing the project officially
- ▶ **Regular reviews** of progress against plan and against the Business Case
- ▶ **Flexible decision points**
- ▶ Controlled management of deviations from the project plans thanks to the **Management By Exception principle**
- ▶ The involvement of management and **stakeholders** at the right time and place during the project
- ▶ **Good communication** amongst the project management team, the stakeholders, and the rest of the organisation

PRINCE2 Foundation Course

The PRINCE2 Foundation Course covers the whole of the syllabus of PRINCE2 Foundation Level and prepares participants for the **PRINCE2 Foundation examination**.

This level is aiming to measure whether a candidate could **act as an informed member of a project management team** on a project using the PRINCE2 method, within an environment supporting PRINCE2. To this end they need to show they **understand the principles** and terminology of the method.

This is a **three day course**, delivered as a classroom event and is designed for people who require a general level of PRINCE2 understanding. The training is structured in order to follow the sequence of a typical project. From the start attention will be paid to initiation, organisation, the control of project stages, and the management of risk, quality, controls, the delivery of the project's objectives and the project closure.

Objectives

Following the completion of the course participants should:

- ▶ Understand the purpose and responsibilities of all **PRINCE2 roles**
- ▶ Understand the seven **principles**, the seven **themes**, the seven **processes**, and the Product-based Planning and Quality Review techniques
- ▶ Understand which **management products** are input to, output from, and updated in the seven processes
- ▶ Understand the purpose of all management products and the composition of the **Business Case**, Product Descriptions, Issue Report and the Issue, Risk and Quality Registers
- ▶ Understand the relationship between principles, processes, themes, products and roles within a PRINCE2 project

It is desirable but not essential that participants have some experience of working on projects.

PRINCE2 Practitioner Course

The PRINCE2 Practitioner Course provides an opportunity to apply the concepts of the PRINCE2 methodology to a scenario and prepares participants for the **PRINCE2 Practitioner examination**.

This level is aiming to measure whether a candidate could apply PRINCE2 to the running and managing of a non-complex project within an environment supporting PRINCE2. To this end they need to exhibit the competence required for the Foundation qualification, and show that they can **apply and tailor PRINCE2** to address the needs and problems of a given project scenario.

This is a **two day** classroom based course, mainly aimed at Project Managers, and is very detailed with the **focus on scenarios**. Exercises will be based on a case study with a similar format to that used in the APM Group Practitioner Exam. This **case study** will be used to test the thorough understanding of the application of PRINCE2.

Objectives

Following the completion of the course participants should:

- ▶ Know or comment on detailed explanations of all processes, themes and techniques, and worked examples of all **PRINCE2 management products as they might be applied** to address the particular circumstances of a given project scenario
- ▶ Demonstrate that they understand the **relationships between processes, themes, techniques** and PRINCE2 management products and can apply this understanding
- ▶ Demonstrate that they understand the **reasons behind the processes, themes and techniques** of PRINCE2
- ▶ Demonstrate their understanding of how to **tailor PRINCE2 to different project environments**

The Foundation exam must have been passed if attending the final two days of the course.
